If I am applying for a PREFERRED or STANDARD service, I agree to install and connect a natural gas water heater or primary heating system within 12 months of my service line installation. Failure to do so will require me to pay the entire installation cost for the service line. This amount is calculated at \$6.00 per foot of installed gas service and must be paid in full prior to the installation of the gas meter, along with any associated fees as described below. Unless these conditions are met or the entire expense is paid in advance, this gas service will not be activated for use and all monies paid will be forfeited.

	\$200 Casual Service	All Footage billed at \$6.00 per foot. (no minimum appliance requirement)

	\$50 Service Relocation	All footage billed at \$6.00 per foot. Plus a (minimum \$50 fee)

AGREEMENT

Any service line footage must be paid in full prior to the installation of requested service. A Fort Hill representative will select the proposed meter location. Upon inspection of the site, if excess footage is required, the representative will prepare a quote for the additional expense of the service installation. The installation will not be scheduled until the full amount of the quote is paid. The proposed meter site will be identified by placing a flag at the selected location. If the selected site is not suitable, the customer must immediately notify the Engineering Dept. to discuss a possible alternative route. The relocation (after the gas service has been installed) will be a minimum of \$50 plus \$6.00per foot for all pipe used. Fort Hill Natural Gas Authority and/or its contractors is hereby granted the right and easement across said premises (at the above service address) within a right of way strip having a width of 7.5 feet on each side of centerline determined by pipe and necessary apparatus, to include regulators and meters (above ground) for transporting, regulating, and metering natural gas. Fort Hill Natural Gas Authority and /or its contractors is not responsible for the replacement of any species, of grass or sod, trees, shrubs or any other landscaping items within 7.5 feet each side of installed gas line. The customer is responsible for locating all "privately owned" underground utilities, including but not limited to, sprinkler systems, water lines, television cables, septic tanks, drain lines, etc and provide sufficient and accurate information of the location of such utilities. If this application is in association with a proposed gas main extension project, and if the requirements for the project are not met by the given termination date, this fee will be refunded. **RESIDENTIAL SERVICES:** Excess flow valves will be installed on all new and/or replaced residential services. The customer understands that there may be a necessity for future maintenance, inspection, replacement or operation of the excess flow valve requiring additional excavation. All natural gas piping will be installed per the International Fuel Gas Code(IFGA). It is the customer, owner and/or builder's responsibility to verify permits and liability insurance meet local codes.
